Who is responsible for the processing of your data?

For what purpose do we collect your data?

On this website, personal data is collected through different forms. The data requested in each form is necessary for the purpose for which it is collected. The purpose of treatment are as follows:

- CONTACT FORM: The purpose of data collection in this form is to be able to answer the queries raised and send the user the requested information through the email or telephone number indicated in the form.

- NEWSLETTER SUBSCRIPTION FORM: The purpose of data collection in this form is to register the user in the company newsletter, through which they will receive information about the offers, promotions, products, activities carried out by the company. Once registered, the user will receive an email to confirm the subscription to the newsletter.

- WORK WITH US FORM: The purpose of data collection in this form is for the applicant to be part of the personnel selection processes carried out by PRODESA MEDIOAMBIENTE S.L ..

- EMAIL: If the user gets in touch through the email published on this website, their data will be processed to answer the queries raised and to be able to send the requested information through the email through which the query is received.

How long do we keep your data?

The data provided by the user will be kept until the user requests its deletion.

Do we make profiles with your data?

With the data entered by the user, no automated decisions or profiles will be made.

What legitimizes the processing of your data?

The data processing is legitimized in the consent given by the user by accepting our privacy policy or by sending us an email through the mail published on the web.

The user must fill in the fields marked with * in order to send the completed forms, if the indicated fields are not filled in, the user will not be able to send them.

To whom do we transfer your data?

Your data will not be disclosed to third parties unless there is a legal obligation.

What third parties provide services on this website?

The following service providers are used to develop this website:

Hosting: The servers where our website is hosted are located in the EU. It uses the TLS 1.2 protocol, with which data communication is done through an encrypted channel.

What rights do you have and how to exercise them?

The user has the right to:

- access your personal data,
- request the rectification of personal data that are inaccurate
- request its deletion when, among other reasons, they are no longer necessary for the purposes for which they were collected.
- request the limitation of their treatment, in which case they will only be kept for the exercise or defense of claims.
- ask for the portability of your data.
- For reasons related to your particular situation, you can oppose their treatment and PRODESA MEDIOAMBIENTE S.L. will stop treating them, except for compelling legitimate reasons, or the exercise or defense of possible claims.
- The user may revoke the consents provided at any time

The user may also file a claim with the Spanish Agency for Data Protection.
